To ILAE chapters

As you are well aware, we are in the process of electing the members of the ILAE Executive Committee with the voting to be completed by May 3rd 2009. Immediately afterwards, the Regional Commissions will have to hold their elections, to be completed before the Budapest International Congress takes place. Five members will be elected in each regional commission.

To speed up the process, I would like to recommend that each region initiates the nominating process with the submission of the names of candidates for election to the respective regional committee by **April 27th 2009**. Each chapter is asked to nominate 5 candidates. The President or Secretary of the Chapter (or equivalent person) should complete the attached nomination form and send it to the designated notary (see below). Each Chapter must submit only one nomination form.

The number of nominations will be tallied using the one vote per chapter rule. The 10 nominees who receive the highest number of votes will be included in the final ballot to be sent out on **May 11th** to be voted by the regional chapters. The final election will be completed before the Budapest International Congress. Please note that anyone currently running for election in the Executive Committee, and not elected, will be automatically added in the final ballot, if they so wish.
