A. Personal Statement

I am head of the Paediatric Neurology service for Red Cross War Memorial Children's Hospital. This is a University teaching hospital, it is the largest children's hospital in sub-Saharan Africa which cares for children from across the region. Child neurologists are scare in Africa and as a result I care for children with diverse neurological conditions. However about 60% of the workload relates to children with epilepsy. Africa carries the highest burden for epilepsy worldwide. My centre is unique since we have capacity to care for children with epilepsy from a primary to a quaternary level of care inclusive of epilepsy surgery. Above all I am a clinician but as part of my post I have roles in training, education, research and advocacy. I am Secretary of the International Child Neurology Association, on the executive board of the Paediatric Neurology and Development Association of Southern Africa (PANDA-SA) and the African Child Neurology Association (ACNA). Chair of the Commission on Pediatrics for the International League Against Epilepsy (ILAE) and Education officer for the Commission on African Affairs. I am director of the African Paediatric Fellowship Program – a training program under the auspices of the University of Cape which develops skills in paediatric disciplines of doctors from across Africa. As a busy full-time clinician my priorities are with the patients directly under my care but I also support education to raise awareness and optimal care for people with epilepsy, training of specialists to increase the capacity of child neurologists in Africa, research to identify clinically relevant data to improve on practice and advocacy to ensure the rights of children with epilepsy are met.
