(4) I have previously served as Chairman of the ILAE/IBE Epilepsy Research Advocacy Task Force (RATF), Co-chair of the ILAE/IBE Global Outreach Task Force.

I am a trained neurosurgeon and neuro-epidemiologist. I work with epilepsy specialists from different disciplines, as demonstrated in my leadership in the CAAE, with its executive members consisting of professional of different background. I am also familiar of working in a multi-cultural and multi-national context, in my previous position as Assistant Director General of WHO and WHO Representative in South Pacific.

With your kind support, once elected, I assure you that I will do my best to work together with you to further develop the global epilepsy control movement through the Global Action Plan, including to reduce treatment gap especially in the low-and middle income countries (LMICs), navigate further growth of epilepsy net-working, promoting multi-center collaborative research, and to promote the quality of life of the people with epilepsy.
